The group is comprised of representatives from Te Kotahitanga o Ngā Hapū Ngāpuhi Taiwhenua (Kotahitanga) and the Tūhoronuku Independent Mandated Authority (Tūhoronuku IMA) who entered into a focused engagement process in December 2015 to find a unified pathway forward towards settlement with the Crown.

The Crown, through the Office of Treaty Settlements and Te Puni Kōkiri, also participated in the engagement group, providing advice on Crown policy and other assistance as required.
